

# REGULAR COUNCIL MEETING

June 7, 2021

5:30 P.M.

The Haleyville City Council met in Regular Session in the Courtroom at the Haleyville City Hall at 5:30 P.M. on June 7, 2021. Jeff Mobley provided the invocation.


