WHEREAS bids for the 2020 Neighborhood Improvements, 7th Avenue South – Mineral Springs Apartments, Streets, Drainage, Water, and Sanitary Sewer, CDBG Project No. LR-CM-CP-20-021, were received on Wednesday, May 19, 2021, at 10:00 a.m., by Project Engineer, Calvin Cassady, P.E., in the Court Room at Haleyville City Hall. Three bids were received for this project and are outlined below:

WHEREAS, Robinson and Sons Construction Services, Inc. deviated from the contract documents by overbidding the mobilization amount by 2.5%. The bid amount should have been a maximum of 5% of the total Base Bid. The amount bid by Robinson and Sons Construction Services, Inc. was 7.45% of the total Base Bid. The rule of the maximum of 5% of total Base Bid allowed for mobilization is to keep the unit price bids balanced. Alabama Bid Law gives the Owner the right to overlook minor technicalities in the bidding process. Awarding this project to Robinson and Sons Construction Company, Inc. will save the Owner \$100,375.00.

WHEREAS, the Project Engineer, Calvin Cassady, P.E., has reviewed this bid as well as the minor technical error and recommends that, pending approval from the Alabama Department of Economic and Community Affairs (ADECA), this project be awarded to the lowest responsive bidder, Robinson and Sons Construction Services, Inc., for the Base Bid of \$536,670.00.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Haleyville, that Mayor Ken Sunseri is hereby authorized to execute the attached Notice of Award in the amount of \$536,670.00 to award this project to Robinson and Sons Construction Services, Inc. to construct the 2020 Neighborhood Improvements, 7th Avenue South – Mineral Springs Apartments, Streets, Drainage, Water, and Sanitary Sewer, CDBG Project No. LR-CM-CP-20-021, for the City of Haleyville, Alabama. Also, to execute the contract documents when the proper bonds and insurance certificates are received from Robinson and Sons Construction Services, Inc.
