## REGULAR COUNCIL MEETING

## October 18, 2021 5:30 P.M.

The Haleyville City Council met in Regular Session in the Courtroom at the Haleyville City Hall at 5:30 P.M. on October 18, 2021. Jeff Mobley provided the invocation.

Mayor Ken Sunseri called the meeting to order and stated the following members were present: Mayor Ken Sunseri, Councilmember Brian Berry, Councilmember Blue Russell, Councilmember Drew Thrasher and Councilmember Julie "Boo" Brooks. Absent – None. Acting City Clerk Christy Harbin and City Attorney Jeff Mobley were present.

Councilmember Drew Thrasher made a motion for approval of the Regular Council Meeting minutes of October 4, 2021, and his motion was seconded by Councilmember Julie "Boo" Brooks.
