

# REGULAR COUNCIL MEETING

**March 21,2022**

**5:30 P.M.**

The Haleyville City Council met in Regular Session in the Courtroom at the Haleyville City Hall at 5:30P.M. on March 21, 2022. Jeff Mobley provided the invocation.

Mayor Ken Sunseri called the meeting to order and stated the following members were present: Mayor Ken Sunseri, Councilmember Ray Boshell Councilmember Julie “Boo” Brooks, Council Member Blue Russell, Councilmember Brian Berry, and Councilmember Drew Thrasher. 
Councilmember Ray Boshell thanked the City Hall and Haleyville Highschool for participating in the Lion’s in Leadership Project.


Councilmember Brian Berry welcomed the new Police Officers.
