## REGULAR COUNCIL MEETING

## March 7,2022 5:30 P.M.

The Haleyville City Council met in Regular Session in the Courtroom at the Haleyville City Hall at 12:00 P.M. on March 7, 2022. Jeff Mobley provided the invocation.

Mayor Ken Sunseri called the meeting to order and stated the following members were present: Mayor Ken Sunseri, Councilmember Ray Boshell Councilmember Julie "Boo" Brooks, , and Councilmember Drew Thrasher. Absent — Councilmember Brian Berry and Councilmember Blue Russell. Acting City Clerk Christy Harbin and City Attorney Jeff Mobley were present.

Councilmember Drew Thrasher made a motion for approval of the Regular Council Meeting minutes of February 22,2022 and his motion was seconded by Councilmember Julie "Boo" Brooks. Judge Lowe will swear the new officers in at the next Council Meeting on Monday March 21st.

Mayor Sunseri gave an update on the medical helicopter that could potentially move to the City's airport in late summer or early fall.

Councilmember Ray Boshell spoke about the upcoming Lion's in Leadership program on March 16th for the Haleyville City School Seniors.

Wyn McAlpine addressed the Council about using City Road's in south Haleyville as part of a logging operation. Mayor Sunseri informed Mr. McAlpine that he and the Council will do some research on the logging ordinances for Winston County and the City of Haleyville and give him a decision at the next Council Meeting.

There being no further business to come before the council, a motion to adjourn was made by Councilmember Drew Thrasher and his motion was seconded by Councilmember.
