

REGULAR COUNCIL MEETING

September 20, 2021

5:30 P.M.

The Haleyville City Council met in Regular Session in the Courtroom at the Haleyville City Hall at 5:30 P.M. on September 20, 2021. Tracy Estes provided the invocation.

Mayor Ken Sunseri called the meeting to order and stated the following members were present: Mayor Ken Sunseri, Councilmember Brian Berry, and Councilmember Blue Russell. Councilmember Julie "Boo" Brooks was present via telephone. Councilmember Julie "Boo" Brooks. Absent – Councilmember Drew Thrasher and Councilmember Jonathan Bennett. Acting City Clerk Christy Harbin was present.

Councilmember Blue Russell read of letter of resignation from Councilmember Jonathan Bennett stating due to moving outside of the Haleyville City Limits, he would be resigning as Councilman effective immediately.




